Privacy Rights of Students STATUTE 20, *UNITED STATES CODE, 1232g and regulations adopted pursuant thereto. It is very important for each student to carefully read and understand the following:

KWA is a Christian-based private school and is not a part of the public school system. We have been involved with education for over 20 years. KWA is not registered with the Federal or State education systems. Therefore, KWA is not listed with them, nor does KWA received any Federal or State funding of any kind.

Concerning acceptance of KWA credits: many colleges, vocational schools and institutions across the USA except the credits from KWA. Many of our graduates are attending, have attended, or have graduated from various colleges, institutions or technical schools. Listed are a few of the institutions or colleges that have accepted KWA credits: Southern Illinois College, Frontier, Rend Lake, John A.
